## **CANCELLATION OF CJCS INSTRUCTION 5128.01**

1. Cancellation. Chairman of the Joint Chiefs of Staff Instruction (CJCSI) 5128.01, 1 October 2014, "MISSION PARTNER ENVIRONMENT EXECUTIVE STEERING COMMITTEE (MPE ESC) GOVERNANCE AND MANAGEMENT," has served the purpose for which it was issued and is hereby canceled.

a. All copies of this, except the Joint Staff official record copy retained by the Records and Research Branch, Information Management Division, Joint Secretariat, should be removed from the files and destroyed.

b. When all prescribed actions have been taken, this cancellation notice may be destroyed.

2. Background. Department of Defense Directive (DoDD) 5101.22E, "Designation of the Secretary of the Air Force as the DoD Executive Agent (EA) for the DoD Mission Partner Environment," aligns MPE governance and management under the Secretary of the Air Force as MPE EA. DoDD 5101.22E negates the need for CJCSI 5128.01.

a. Joint Requirements Oversight Council Memorandum 026-13 assigned the Director, Command, Control, Communications, and Computers/Cyber Directorate (J-6) as the MPE implementation lead.

b. DoDD 5101.22E "Designation of the Secretary of the Air Force as the DoD Executive Agent for the DoD Mission Partner Environment" also established the DoD Chief Information Officer (CIO) as the Principal Staff Assistant with oversight of the DoD EA for the DoD MPE.

c. In accordance with DoDD 5101.22E, DoD CIO, in coordination with the Joint Staff, the Under Secretary of Defense for Intelligence and Security, and the DoD MPE EA, established an executive-level governance body to provide oversight of cross-functional MPE requirements, policies, and capabilities.


